The Katar Light Transport is often used to transport troops, supplies, and cargo using interchangeable cargo modules. There are dropship modules as well as passenger and barracks modules. When these ships begin to get older, say twenty years or more they are often sold to private merchants for use as civilian cargo haulers. The Katar transports have a reputation as sturdy and reliable ships even if they aren't the prettiest.

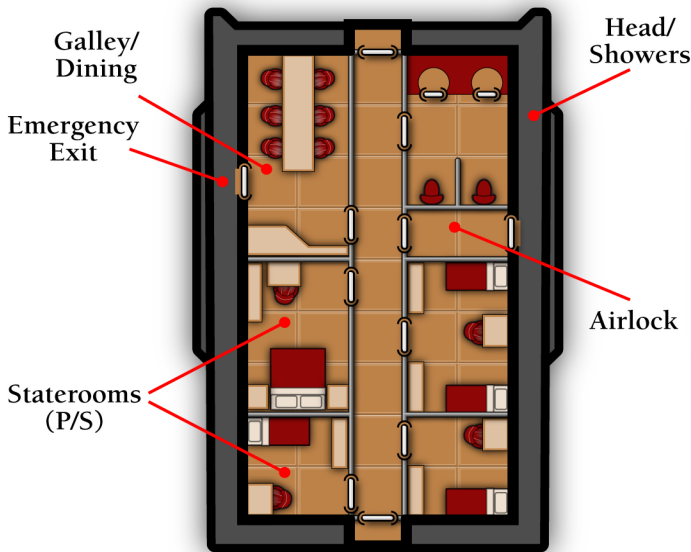
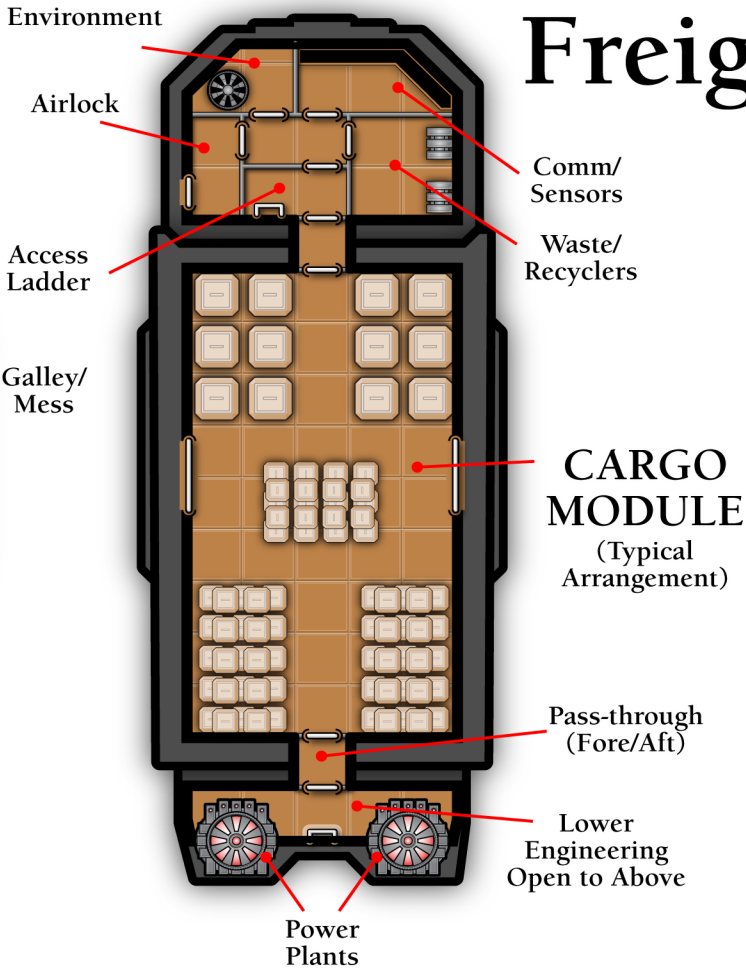
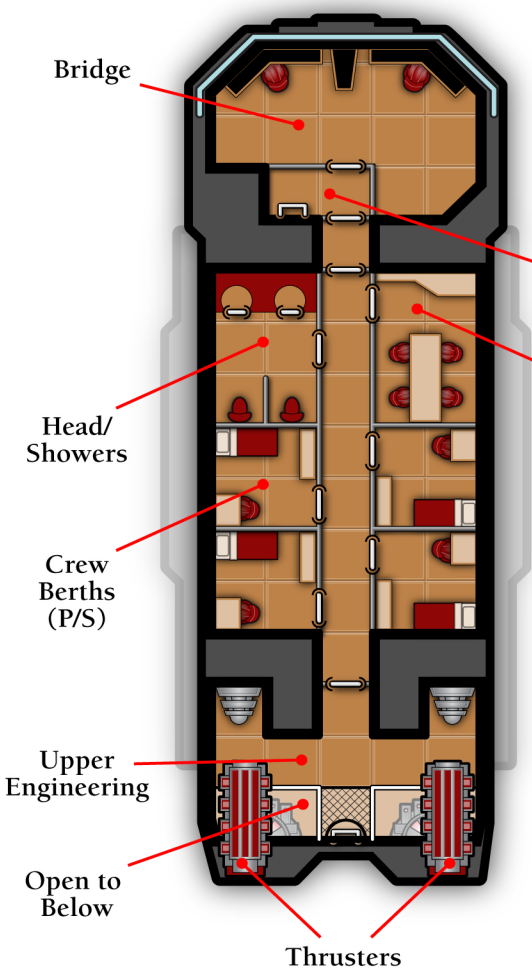




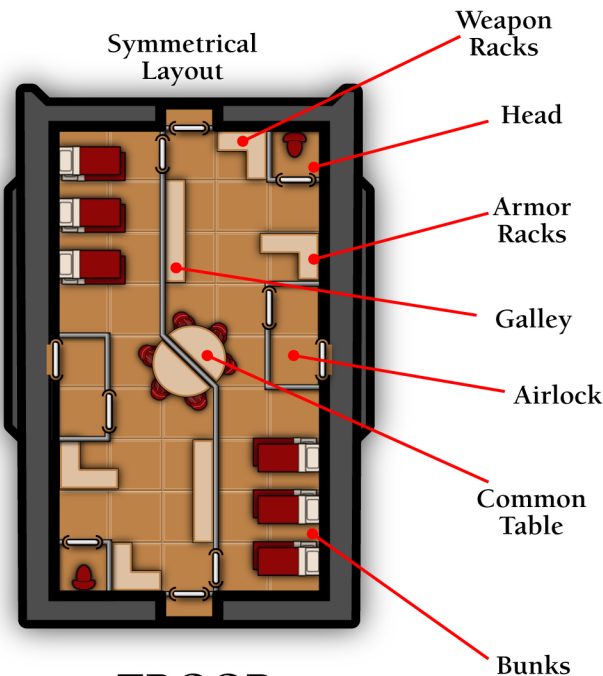
